## **'A Run Through History' Race Waiver**

Knowing these facts and in consideration of acceptance of my entry, I hereby for myself, or for anyone else who may claim on my behalf, agree not to sue and to waive, release and discharge all persons participating in the operation of this event including without limitation Variety, The Children's Charity of Manitoba, City Park Runners, Athletics Manitoba, Sport Manitoba, the City of Winnipeg, the Province of Manitoba, and any and all other organizations, sponsors and participating organizations and their personnel whether volunteer or otherwise, and anyone acting on their behalf (the Release's) for any and all claims, demands, causes of action, damages, or injuries, whether caused by the negligence of the Releases, or by any other cause, which may arise as a result of, or out of my participation in this event.
