8. Office Report

- Thank you to the executive and office colleagues for their support
- We had three coach calls and two athlete meetings, starting to open the lines of communication
- We are now using MailChimp to communicate with members
- Performance Pathway Funding criteria has been updated and an information session for all athletes and parents was held. Coaches and athletes had the opportunity to provide feedback prior to the new structure being finalized
- An expert group to help assess the daily training environment of athletes who receive performance pathway funding has been struck
- A bylaw and policy review is underway and will be completed by September. The AGM date was shifted from November to June as part of this revision.
- The tracks at the University of Manitoba and Brandon will be renovated for the Canada Summer Games and Legion National Championships respectively. Construction is Winnipeg will begin this summer (2015) and Brandon's reno will be next year. Selkirk will also be upgraded in the near future
- We have completed a budget overhaul (thanks to Brian and Alanna). We have moved from Simply Accounting to Quick Books and from a general budget to a project specific format
- The Integrated Funding Framework was submitted to Sport Manitoba in March. Our funding
 is now provided around a four year cycle (quadrennial). The submission was based on the
 outcomes of the strategic planning process Athletics Manitoba engaged in prior to the hire
 of the new executive director.
- An attempt was made to organize a trip to nationals as a provincial team. This did not work, likely because Edmonton is close enough to drive. This concept will be attempted again.
- An Assistant Provincial Coach (horizontal jumps) and Membership and Communications
 Coordinator was hired (Alanna Boudreau). Shirley will be transitioning to retirement in the
 coming months.
